The announcements to be made are READY, NON-JURY, REQUEST CONTINUANCE OR NOT READY. If you announce "request continuance" or "not ready," you will need to submit a detailed explanation for that announcement. **If you announce Non-Jury, all attorneys will need to sign a Waiver of Jury Trial.**

Conflict letter or leave of absence will not relieve you from making an announcement to court.

The Court does not require pre-trial orders as a matter of course. If the parties desire a pre-trial conference and/or pre-trial order as provided in Superior Court Rules 7.1 and 7.2, this should be scheduled with the Court prior to the calendar call date listed herein, or such request will be deemed waived. In no event shall the failure to request a pre-trial conference and/or order be a reason to continue the matter from the trial calendar.

All orders for cases settled prior to trial, previously disposed of by trial or settlement are to be filed no later than 5:00 p.m., Monday, February 13, 2023.

Pursuant to Uniform Rule 20, if a party fails to answer when the Court calls their case during the court term, the Court may dismiss the case, any claims, or a party's pleadings. It is also the party's duty to be sure that the Clerk of the Superior Court of Morgan County has their accurate telephone numbers and mailing addresses.
