Once all documents are uploaded SCROLL to the bottom right and click NEXT in Blue

YOU WILL RECEIVE AN EMAIL WHEN YOU EFILE, ANOTHER EMAIL WHEN IT IS ACCEPTED BY THE COURT. WITHIN 15 MINUTES OF THE EMAIL OF ACCEPTANCE THE DOCUMENT SHOULD BE AVAILABLE FOR REVIEW IN YOUR EZFILE ACCOUNT.
